

## **CONSULTATION – PROPOSED MERGER WITH RIVER LEARNING TRUST**

14th June 2024

Dear Parents, Carers, Families and Friends of Meadowbrook College

In recent years many smaller educational trusts have undergone mergers to form larger trusts. As with all strategic change, a merger can bring significant advantages but also some challenges.

Over the last year, the trustees of Radcliffe Academy Trust (RAT) have been considering the opportunities and challenges that a merger with a multi-academy trust (MAT) might bring to Meadowbrook College. After a detailed analysis and consultation, the trust board has concluded that a merger with a like-minded trust would bring significant benefits to both the students and staff.

Following extensive research and through discussions with various multi-academy trusts, the trust board has decided that the River Learning Trust offers many potential benefits and would be best placed to support Meadowbrook College in providing high quality alternative provision across Oxfordshire schools.

By way of background, RLT is a local academy trust with 26 Oxfordshire schools (8 secondary and 18 primary) and is already committed to supporting the work of the wider Oxfordshire education system through its Teaching School Hub, Oxfordshire Teaching School Hub, and School Centred Initial Teacher Training provider, Oxfordshire Teacher Training. RLT is committed to ensuring that Meadowbrook College continues to support all of Oxfordshire's schools. Further details can be found in the FAQs document.

We now need to hear your views on this proposal. You are a key stakeholder and your opinion will be very important as part of the consultation process being carried out by the trust board. I hope you will take a few minutes to read the information attached, which explains the key issues behind the proposal for Meadowbrook College to join River Learning Trust.

A form is also provided for you to give us your feedback and to raise any questions you may have. The questions will be answered by the most appropriate person and I will also set out the answers to Frequently Asked Questions which will be added to our website.

You may want to have a discussion about our ideas and how this might impact your child's education. To give you this opportunity we will be holding a virtual meeting on Thursday 4th July 2024 from 1600 - 1700.
